

PROPERTY OVERVIEW

Los AltostPlaza is located in the NE Heights of Albuquerque with great leasing opportunities. The two remaining vacancies in this center are Suite A-6 consisting of 2,500 SF - 6,442 SF and suite B-1 consisting of 3,365 SF. Suite A-6 is an open floor plan demisable and adaptable to most retailers and B-1 is a corner suite currently built out as an office but easily adaptable to retail use. Suite B-1 was formerly an architect's office and most recently a dental training facility. It has an open ceiling concept with a few existing private offices and storage areas. Located in the elbow of the center with a secure private gated entrance and a covered courtyard. The center includes retailers Golf Mart, Eyeglass World, The Open Gym, and Down and Dirty Seafood Boil.



This area within the NE Heights is being redeveloped in a big way, which directly impacts the Los Altos Plaza. Across the street, the former La Mirada Shopping Center has been torn down. The plans are to create more residential housing with individual retail pads to be developed along Wyoming and Montgomery. What that means to Los Altos Plaza is a significant lack of available property in the immediate area, along with new restaurant and retail services being added to this redeveloping area. The intersection of Wyoming and Montgomery boasts over 65,000 cars per day and is the 3rd highest trafficked intersection in the city.








