\$139,597.00 AVG HH INCOME 3-MILE RADIUS




2,255 DAYTIME POPULATION3-MILE RADIUS

PROPERTY OVERVIEW

19 Cirquela has been the longtime home to the Villa Santa Maria, a nationally and internationally recognized early childhood treatment facility that aided thousands of children and their families until their closure in 2022. The property is comprised of a total 21,224 SF on 9.32 acres, including a dormitory featuring 32 beds, admin office, school house and a log cabin on 4 land parcels. The possibilities are endless here as this site could be used again for another treatment facility or could be used for an assisted living or nursing home, youth retreat, church, school, yoga retreat or a number of other businesses looking for an outdoor campus with room to grow. The property also features a state-of-the-art soccer field, a volleyball court, basketball hoop, orchard, outdoor playground, cafeteria, laundry room and its own wastewater treatment facility. The campus is nestled between two large ridges and has the Acequia de Madre running directly to the west, and the San Antionio Creek to the east.



The facility is located in Cedar Crest, NM, just seven miles east of Albuquerque in the iconic Sandia Mountains. This secluded resort is hidden off Highway 14 (commonly known as the Turquoise Trail), yet is a quick mile from Interstate 40. Cedar Crest is a popular mountain community filled with communities of custom residential homes, local eateries and nearby the popular Sandia Ski Area and Golf Digest's Top 20 Public/Private Golf Course (Paako Ridge) to the north. Any buyer of the property will appreciate the quick access to Albuquerque's airport and the state's largest healthcare network, while having the tranquil resort feel of Cedar Crest.
